USCIS Clarifies EB-5 Regional Center Re-designation

The USCIS held a listening session Friday, April 29, to inform industry stakeholders of changes that will take effect on regional centers. One such change being that the agency is requiring all entities that want to be designated as a regional center to file Form I-956 -- even those that were previously designated under Form I-924.

We had a call with USCIS to express our concerns, as this was not expressly stated in the EB-5 Reform and Integrity Act of 2022. We are hopeful that they will provide an expedited process for re-designation to Regional Centers designated under Form I-924. There will be a follow up call at the end of May for the USCIS to provide further guidance.
