Following Settlement With USCIS, IIUSA Sets a New Course for the EB-5 Community

The EB-5 Reform and Integrity Act of 2022 was passed by Congress as a part of the Consolidated Appropriations Act of 2022. The bill highlights the major implications for existing and future investors, regional centers, developers, and promoters. The new legislation will not only revive the Regional Center program, but it will introduce other integrity measures to be applied to all parts of the new EB-5 program.

Background: Congress created the EB-5 Program in 1990 to stimulate the U.S. economy through job creation and capital investment by foreign investors. In 1992, Congress created the Immigrant Investor Program, also known as the Regional Center Program, which sets aside EB-5 visas for participants who invest in commercial enterprises associated with regional centers approved by USCIS based on proposals for promoting economic growth.
